The Eye Clinic provides free eye exams for Oklahomans without eye care insurance. Eye exams are by appointment only and the number is limited only by the number of doctors who donate their time. The Eye Clinic fills glasses prescriptions from any county. The fee for making the lenses is \$45.00 for single-vision lenses and \$65 for bifocal lenses (lined bifocals only). We provide the first pair of glasses free of charge to Oklahoma County schoolchildren. Students are bumped to the top of our waiting list.

The Style Shop Special Occasion section offers school uniforms to at-risk children. Families are referred by school counselors or DHS. Each child is given two new, well-fitting school uniforms, three pairs of socks, three pairs of underwear and a new pair of athletic shoes.

Skyline's Food Resource Center Store operates as a "choice pantry" where the patrons select their own groceries, based on their family needs and food preferences. The Food Resource Center is open varying hours Monday thru Saturday (except on holidays). In addition to the brick and mortar Store, Skyline has a mobile pantry which delivers groceries to 12 sites each month The Food Resource Center serves mainly those living in Oklahoma County. In 2021, Skyline provided 1,190,594 pounds of groceries to 32,668 individuals.

Skyline's Wellness Programs offer health screening, nutrition, movement and concepts of wellness and preventative education to the patrons of its programs. Ongoing health messages encourage life style changes are delivered daily via posters, flyers and presentations. Activities communicating nutrition, movement and wellness and disease prevention are offered during each week: including food/meal demonstrations, recipe selection, healthy cooking options, portion size, and chair exercises. The healthcare providers serve as a health check, a liaison and an educator, working to help Skyline empower patrons to improve their health and the health of their families.
